Continue to reduce, reuse and recycle materials to minimise waste production.



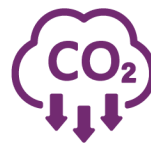
Energy Efficiency

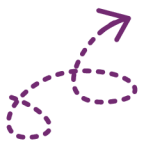
